All storage fees, once received, are final, non-transferrable and un-refundable after receipt by the Marina.

This Agreement shall, commence on the date this Contract is signed (or October 1st) whichever is first and shall continue for the period specified in the contract form and, thereafter, this Contract shall be automatically renewed for successive periods of the same length (each a Renewal Period) that the vessel/boat/trailer/dinghy remains at Port Milford.
